

## Miss Indian Arizona Scholarship Program

#### Greetings!

Thank you for your interest in participating in the Miss Indian Arizona Scholarship program. Enclosed, you will find materials that describe all aspects of the program. This packet is composed of several sections, these are:

- Eligibility Criteria Participants in the Miss Indian Arizona Scholarship Program must meet the listed criteria
- MIA Regulations These regulations must be followed by Miss Indian Arizona, as well as the 1st and 2nd Attendants
- MIA Duties These are the duties that Miss Indian Arizona and her court will be expected to fulfill
- Scholarship Rules These rules apply to scholarship funds awarded to Miss Indian Arizona, as well as the 1st and 2nd Attendants
- Program Rules These rules pertain to the Scholarship Program, and should be read thoroughly. Failure to comply with these rules could potentially result in lost points or disqualification.
- Application Checklist Using this checklist will help you ensure that your application packet is complete and the checklist must be submitted with your application
- Application Participants must fill out the 3 page application completely. You are also required to submit the following, which are included as a part of your application:
- Physician's Statement The original form must be completed and submitted
- Description of Talent
- Description of Traditional Dress
- Essay

You must also submit the following documents with your application:

Two letters of recommendation Proof of tribal enrollment Copy of official grade transcripts Description of your Community Color photo in tribal dress in two sizes 8 x 10 & 4 X 6



## MISS INDIAN ARIZONA ELIGIBILITY CRITERIA

- You **must** be an enrolled member of a federally recognized tribe within the State of Arizona, and a resident of Arizona.
- You **must** be at least seventeen (17) years of age and be no older than twenty-six (26) years of age at the time of the Miss Indian Arizona Scholarship Program.
- You are and you have always been a female.
- You are not now and you have never been married.
- You are not now and you have never cohabitated.
- You are not now pregnant, and you have never been pregnant. You are not the adoptive parent of any child.
- You are of good moral character and have not been involved at any time in any act of moral turpitude.
- You have never been convicted of any criminal offense, and there are no criminal charges presently pending against you.
- You do not use, possess, or consume any illegal controlled substances or abuse the use of alcohol or other dangerous substances.
- You are in good health and can, to the best of your knowledge, participate fully and without limitation in any Program activities. Any current medical condition or disability will not impede your ability to complete your year of service or fulfill your obligations.
- You must be knowledgeable of your culture, history, values, traditions and issues of your tribe and current issues of all Arizona Tribes.
- You must have a high school diploma or GED or be currently attending high school, GED classes, college or technical school and plan to continue your education toward obtaining a degree. You must have a grade point average of 2.0 or higher (on a 4.0 scale).
- You must not be registered for active duty with any military service.
- You must not have previously held the title of Miss Indian Arizona.
- You must be willing and able to communicate with the public.
- You must comply with all program requirements, rules, and regulations.
- You must participate in all program activities.



#### **MISS INDIAN ARIZONA REGULATIONS**

Participants must read these regulations carefully to understand and prepare for participation in the Miss Indian Arizona Scholarship Program. Miss Indian Arizona and her court represent themselves, their families, and all Indian people in the State of Arizona and are expected to uphold their titles with respect, honor and dignity. Miss Indian Arizona and the 1st and 2nd attendants must adhere to the following regulations:

- Must relinquish any tribal titles or crowns if selected as Miss Indian Arizona, 1<sup>st</sup> or 2<sup>nd</sup> Attendant. Waivers may be requested for royalty titles with 3 months or less remaining at the time of the Miss Indian Arizona Scholarship Program.
- 2. Must maintain Arizona residency throughout the year of service.
- 3. Traditional dress must reflect the Arizona tribe that they represent.
- 4. Shall serve for one year.
- 5. Will travel as designated by the Miss Indian Arizona Association and will travel with an adult female (25 years or older) chaperone approved by the Association. Miss Indian Arizona may also travel with an adult male who is a member of her immediate family (father, step-father, brother, etc.). If an adult member of Miss Indian Arizona's family is unable to serve as chaperone for an approved event, she must inform the Executive Director no less than one week prior to the event.
- 6. Must not marry or cohabitate during the year of their reign.
- 7. Must not become pregnant during the year of their reign.
- 8. Must not be seen in bars, frequent liquor establishments, use alcohol or illegal drugs, including tobacco products or use profanity at any time during their rein.
- 9. Pregnancy, incarceration, conviction of a crime, use of alcohol or illegal drugs, marriage and cohabitating shall be immediate cause for relinquishment of Miss Indian Arizona titles. In the event of relinquishment all benefits, royalties, gifts, and honors derived from the scholarship program and reign shall be returned to the Miss Indian Arizona Association.
- 10. Must not seek any other title during reign as Miss Indian Arizona title holders. Should another title be sought, relinquishment of Miss Indian Arizona titles will be immediate.



#### **MISS INDIAN ARIZONA DUTIES**

- Miss Indian Arizona (MIA) and her court will always be positive role models and are expected to conduct themselves at all times in a manner above reproach.
- Miss Indian Arizona or the first or second attendant will appear on time at all scheduled events. Should an emergency arise which prevents an appearance, immediate notification will be made to the Miss Indian Arizona Association (MIAA) Executive Director.
- Miss Indian Arizona will set a goal related to her platform that can be reasonably achieved during her reign in the area of community service. The goal must be submitted to the Miss Indian Arizona Association within 90 days of her crowning.
- Miss Indian Arizona is responsible for the care and safe-keeping of the crown and sash during her reign and is financially responsible in the event of loss or damage to the crown. The crown is a perpetual crown, which will be handed down to the next MIA and remains the property of the Miss Indian Arizona Association.
- Miss Indian Arizona and her court are considered members of the Miss Indian Arizona Association and will present a written quarterly report to the Miss Indian Arizona Association during regular scheduled meetings.
- Miss Indian Arizona and her court members will take an active role in recruiting future participants in the Miss Indian Arizona Scholarship Program.
- Miss Indian Arizona is responsible for planning and executing her farewell event to be completed before September 15th of her reigning year. Thirty-day notice of the event will be given to the Miss Indian Arizona Association.



# MISS INDIAN ARIZONA SCHOLARSHIP PROGRAM RULES

Each Tribe may be represented by no more than two participants. Participants may be tribal royalty sponsored by a Tribe or "At Large" participants, sponsored by a Tribe, a family, organizations, businesses, etc. The first two complete applications received from a Tribe which met the eligibility criteria will be the tribal participants.

Participants will be judged in **five** categories: Personal interview, talent, evening dress, traditional dress, oral presentation.

Special scholarship awards will be presented for Best Essay and Best Community Service Paper. Points for these two scholarship awards are not computed in the overall selection of Miss Indian Arizona.

Miss Indian Arizona Scholarship Program participants must be on time for all scheduled events (i.e., workshops, activities, rehearsals, etc.) unless advance permission is granted for an absence by the Miss Indian Arizona Association.

A two-minute talent presentation is required. You must provide a written description which will be used in your introduction. The talent presentation may be either traditional or contemporary in nature (i.e., singing, dancing, explanation of a tradition of your tribe, etc). You may use pre-recorded music as background to your presentation. You must provide a CD clearly marked with your name for rehearsal and program use. No other individual will be allowed on stage during the talent presentation. Any accompaniment must be off stage. Presentations, which are over **two** minutes, will be penalized 10 points.

The use of stage props will be limited to those that will be physically utilized by the participant. All props must be approved by the Program Director.

A two-minute oral presentation based on the Scholarship theme is required. Oral presentations are spoken words. Oral presentations shall not include the following: singing, sign language, dancing or audience involvement. Oral presentations which are over two minutes will be penalized 10 points.

The use of video, power point and/or slide projections is not allowed in any presentation.

You must provide a description of your traditional dress. The description should ha a minimum of 120 words and a maximum of 180 words.

You must wear a floor/ankle length gown for the Evening wear portion of the program. A 10-point penalty will be assessed to participants who disregard this rule.

You must submit an essay based on the scholarship theme.

You must submit a paper describing your community service work.

You must submit two letters of recommendations and a description of your community.



#### MISS INDIAN ARIZONA SCHOLARSHIP AWARD RULES

Participants are responsible for reading/complying with all scholarship rules.

These rules apply to Miss Indian Arizona and the First and Second attendants.

Scholarship funds shall be expended for tuition and related educational expenses. Room/board and other educational expenses must be approved by the Executive Director of the Miss Indian Arizona Association. Room /board will not be reimbursed for contestants living at home or with relatives.

# Requests for scholarship funds are processed upon receipt of proof of enrollment, (Registration & class schedule) and receipt of invoices for education expenses.

Scholarship funds may be used for current educational expenses. Participants may submit invoices for payment directly to the provider of the educational service or may submit a receipted bill and request reimbursement. All invoices and receipts must be originals.

Scholarships may be used for future education expenses. Participants must begin use of their scholarships within one year of the date of the award. If a contestant has no activity in her scholarship account during this period, the funds in her account will be forfeited.

A participant, who begins use of her scholarship within time designated above, will be required to show continuous activity in her scholarship endeavors up to the limit of four years following the date of the award.

An exception to the time limits described above maybe made if a participant, prior to the four year expiration date, makes a written appeal to the Miss Indian Arizona Association citing compelling reasons for the time extension. The Association will review request and determine if an extension is warranted.

#### Scholarships, which have been forfeited, will remain in the scholarship account for future awards.

All Association decisions are final and binding.

#### **DESCRIPTION OF TALENT**

A two-minute talent presentation is required. The talent presentation may be either traditional or contemporary in nature (i.e., singing, dancing, explanation of a tradition of your tribe, etc). You may use pre-recorded music as background to your presentation. If you have background music, you must provide a CD clearly marked with your name, for rehearsal and program use. Please bring background music to orientation. No other individual will be allowed on stage during the talent presentation. Any accompaniment must be off stage and must be available for rehearsal.

The use of stage props will be limited to those that will be physically utilized by the participant. All props must be approved by the Program Director.

You must provide a description of your traditional dress. This description is used to write the script for the traditional dress portion of the evening program. # **ORAL PRESENTATION**

A two-minute oral presentation based on the Scholarship theme is required. Oral Presentations are spoken words. Oral presentations shall not include the following: singing, sign language, dancing or audience involvement.



## **ESSAY COMPETITION REQUIREMENTS**

Participant must write an essay, which reflects the program theme.

Essay must contain a cover page, which contains the Title of the essay, participants name and Tribal affiliation.

Format of the essay: No less than 300 words or more than 500 words typed and double spaced.

Essay must be clear, organized and effective.

Essay must reflect the use of good grammar and punctuation.

Essay must flow smoothly and logically.

Essay conclusion must be logical.



#### **COMMUNITY SERVICE PAPER REQUIREMENTS**

Participant must write a Community Service paper, which should describe her involvement in Community Service/Volunteer work. The paper should include the following:

- . A cover page with the participants name and tribal affiliation.
- . Quality of service participant has provided.
- . Effects of service upon the community and the individual.
- . The participant's commitment to the service.

The Community Service Paper must be accompanied by a letter from someone in the organization which was provided the service verifying participant performed the community service work. The verification letter must be on the organizational letterhead.
